# Reach Act/Founding Documents/Transfer Requirement/Blackboard Module Trena Houp Alexandra Weaver Lydia Frass

- Fall 2020 had to develop courses for compliance with the Reach Act
- Fall 2021 requires all undergraduate students of SC public institutions to complete a 3-credit course
- CHE collects and reviews syllabi for REACH Act
- We had to send a list of all the courses we want to teach for this. There is a list of CHE approved courses
- Fall 2023 clarified for transfer students
  - Beginning fall 2024, transfer student has a transfer course equivalent to one of our courses but in Fall 2024 students should not be approved to take a FND course as a transient student at an non- USC institution unless that course is a CHE approved REACH act course offered at another SC institution.
  - o Implement in spring 2025, but applies to those accepted in fall 2024
  - Do not approve a transient course on SERF form unless it is on the approved list of CHE approved courses
- To cover this for transfer students a module was created
  - o Students with an equivalent but not a CHE approved REACH Act course will be asked to complete an online module that covers the required founding documents
  - Only transfer students with comparable credit
  - Everything is in blackboard, short, abbreviated time 2 hours, transcript to read and
     5 minutes slide show to watch
  - o Take the quiz as many times as you want and score 60%; checkbox to certify they read the documents
  - Not to be a barrier
  - o Trena's office will be monitoring this
- Estimating 200 students in Columbia that will fall into this category
- A custom table was created in Banner to store approved REACH Act (FND) completion pathways to include
  - o institutional courses,
  - o transfer courses,
  - o exam credit,
  - o exceptions,
  - o non-Course requirement completion (BB modules) table includes all the approved courses, AP and IB courses
- Prior to Fall 2024 will be grandfathered into the system. Look at term entry the student is to know if this is going to impact your students
- 3 things happening here
  - o admitted prior to 2021 does not fall under the guidelines original admit term prior 2021
  - o we added an ADMR attribute not required to complete show in self service
  - o Fall 2021 and summer 2024 taken a reach course at USC or equivalent course
  - o Fall 2024 catalog year tighter set of rules
- Founding Documents Self Service page can be found on the student profile;
  - o indicating if it is met,

- o where it was taken,
- o how it was met
- Showed examples of the ways it looks in the different ways it shows on the profile
- Recommending looking to degree works
- SCHC asks if they have reviewed FND courses offered in the Honors College
- Discussion need to figure if we need to have the table not set up to add section level and term specific or do we pull a student and assign an attribute
- Is this related to admit term or bulletin term? We are looking the attribute based on admit term but for DW has to be on the bulletin term good point needs to be looked into
- Incoming students that did dual enrollment and not as an approved one report is looking at transfer students only we need to define that report pulls eligible or non-eligible students. dual enrollment is not included
- Typically, admissions for Lancaster nursing transfers to our campus, admissions will automatically put them under the current catalog year
- Start first two years at Lancaster and admissions puts them under the current catalog and nursing changes it back to original term
- Need to consider the difference between the admit term and bulletin term
- Trena's office can upload students manually in the report
- Lunch and Learn with Amanda Shores will be hosting on this topic
- Data warehouse reports will be available soon
- International students will have to do this requirement
- May need a website with FAQ concerning this subject
- It is under discussion and a one pager for advisors to be shared soon
- Messaging will be going out in the spring semester

#### **Honors Advising updates**

Kay Thomas Ali Mathwig

- Single advising model
  - o Provost charge to consider a single advising model
  - o Phase 1- 1038 students, 45% SCHC students
    - DMSB, Engineering, etc
  - Advising in Navigate under "Your Success Team" list the Honors contact; not assigned in Banner
- Curriculum revision
  - o Honor requirements 44 credits
  - o 9hrs Arts and Humanities, 7hrs Stem, 3hr Social Science, 3hrs Beyond The Classroom, 4hrs Senior Thesis, 18hrs Electives
  - Has been coded into Degreeworks
  - o Recoding 5 years of classes to match new curriculum
- Honors registration process
  - Can search by the categories in self service under advance search in Browse courses
  - o still have the course web page
- Honors student Educational plan (SEP)
  - o Honors advisors can no longer register students for SCHC courses

- o Students will be registering for honors and non-honors at the same time
- o SEP in degreeworks to help students know the requirements areas to look at and if there is a specific course designated in the plan
- O Using the notes features to discuss the courses that are specific for requirements and for the specific course
- o Integrate the information instructions on Sharepoint
- The thesis timeline is in a standard way on the SEP trying to forecast the 3 semesters for this
- Advising workshops Sept 30<sup>th</sup>, Oct 15, and Oct 21 will be discussing how the changes are working along with the curriculum changes and which students the advising model will affect.
- Kay Thomas is the one that students need to discuss leaving the SCHC

- Is there a limit on the certificates a student can do? Students can do multiple certificates
- Look back at past minutes that had questions and make sure all questions were answered concerning the certificates and then make a flier or FAQ for the advisors to refer to when promoting the certificates
- Course fees transparency beyond textbooks cost,
  - o Students can find it on the spring schedule under course description,

 Worked with scheduling coordinators to have this in place for students to plan their schedule and finances

- **Myhealthspace** has an immunization field which will be marked compliant and if not red lettering will show that they are missing something
- Handle before drop/add and before registration for next term
- Can send a question through Myhealthspace portal about the vaccinations needed
- Significant change to how holds were placed this summer for new students this year holds now being placed during the fall semester
- It will prohibit the students from registering for the spring semester
- 1496 student non-compliant as of Oct 7<sup>th</sup>, Communicated with students via email or text message
- Registration Hold went on Oct 14<sup>th</sup> now 1396 students have holds as of yesterday 10/15
- See frequently students forget to answer the TB screen questions
- Hold will not come off until midnight and will not appear off until the following day.
